<sup>1</sup>**Residential care** includes flexible residential care places in the: Multi-Purpose Service (MPS) Program, Aged Care Innovative Pool Program and the National Aboriginal and Torres Strait Islander Flexible Aged Care Program.

<sup>2</sup>**Home care** Following the Increasing Choices changes on 27 February 2017, places for the Home Care Packages Program are now assigned to consumers and not to services. Correspondingly, places data for the Home Care Packages Program are no longer captured in the stocktake and no longer included in the operational aged care provision ratio. These figures only include flexible home care places in the: Multi-Purpose Service (MPS) Program, Aged Care Innovative Pool Program and the National Aboriginal and Torres Strait Islander Flexible Aged Care Program.

<sup>3</sup>**Restorative care** includes places in the Transition Care Program and the Short-Term Restorative Care Program.

**Note:** The ratios in the above table were calculated using revised population projections for June 2022 which are based on the 2017 ABS Estimated Resident Population. These population projections are customised projections prepared for the Department of Health (DoH) by the ABS, according to the assumptions agreed to by DoH. Due to rounding, individual ratios may not sum to the totals.
